THE TWENTY-SEVENTH ANNUAL CONFERENCE ON TYRE RECYCLING

New Market Partnerships after 2020 : Overcoming the Obstacles

Wednesday through Friday 24 – 26 March 2021

The 27th Annual Conference on Tyre Recycling is a two-and-a-half day event offering Plenary and Break-out Sessions, discussion and debate as well as a series of networking activities. The sessions will focus on current industry interests and expanding opportunities for the use of recycled tyre materials in traditional and innovative markets.

The tyre recycling industry faces a number of challenges in its drive towards the Circular Economy. The Conference will explore key challenges and identify a broad array of opportunities for recyclers.

The Plenary Sessions on Thursday will focus on issues confronting recyclers in 2020 and beyond – including the changing roles of recyclers, ECHA findings re SBR and micro-plastics, the Basel Convention, and the impact of exports from the EU. The afternoon will focus on the role of GPP in expanding Municipal use of RTMs in construction, transport infrastructure and maintenance for road, rail, tram and sea as well new opportunities in the automotive sector. Friday Plenaries will focus on New markets for Innovative Materials, Applications and Technologies. The afternoon will explore Pyrolysis as it moves into traditional markets. The final session will identify opportunities to develop strategies to make tyre recycling a key contributor to the Circular Economy.
